## DIA EuroMeeting 2013 Young Professional Fellowship Programme

DIA Europe promotes the participation of young professionals in the annual EuroMeeting by offering up to 15 complimentary registrations for professionals under the age of 32 currently working in the Pharmaceutical Sector. The DIA will waive the registration fee, selected attendees are expected to bear their own travel and accommodation cost.

The Young Professional Fellowship Programme is designed to:

- Increase the involvement of young professionals in the annual DIA EuroMeeting
- Stimulate mutual understanding and cross-culture co-operation
- Allow knowledge acquisition and training for young professionals
- Increase knowledge and develop an understanding of the strategies and concerns of the pharmaceutical industry and regulatory authorities
- Act as a platform for information exchange and networking

The long-term goal of the programme is to develop sustainable participation of young professionals in future DIA EuroMeetings, to facilitate programme development with the help of an enlarged pool of young professionals identified as volunteers and potential speakers, and to enhance awareness of DIA meetings.

An exclusive young professional session on the morning of Monday 4 March 2013 will enable you to get the most out of the conference.
